- 1. This is a provisional grant of recognition under the RTE Act and rules and is not extendable
- 2. The school shall abide by all the provisions of the RTE Act 2009 and the RTE Rules 2010
- 3. The school shall admit in Class I, to the extent of 25% of the strength of the class, children belonging to weaker sections and disadvantaged groups in the neighborhood and provide free and compulsory education till completion of elementary education. Provided that if the school admits children in pre-primary classes also, the school shall follow these norms. The children so admitted shall not be discriminated from the rest of the children or segregated
- 4. For the children referred in paragraph 3. the school shall be reimbursed as per section 12(2) of the Act. In order to receive such reimbursements, the school shall open and maintain a separate bank account which is subject to audit by the department.
- 5. The Society / School shall not collect any capitation fee or voluntary donations from the parents of children at any time either during admission or during the course of the academic year. The school shall collect only tuition and other fee as approved by the department. The scale of fee shall be notified by the school and displayed prominently in the school premises.
- 6. The school shall not subject the child or the parents to any screening procedure including
- Admission shall be made only during the period notified by the department.

8. The school shall not deny admission to any child.
